## ***Meet the students supporting vital work at Salford Foundation***

*As part of a strategic partnership, students from across Schools at the University of Salford have volunteered to provide critical support to vulnerable people at Salford Foundation.*

Working mainly with service users at the charity's **Women's Centre**, many of whom have complex issues, including being victims or survivors of domestic abuse, students are able to test the skills they have learned at University in a real-world environment, while also benefiting the Salford city community.

**Millie**, a recent Law and Criminology graduate of University of Salford's Business School, successfully applied for a student placement working with the *SILKS* law clinic. This allows students to help advise on legal matters within the community alongside qualified solicitors. Millie worked closely with the Women's Service team, Millie provided pro bono legal advice to service users; working on complex cases anchored in the principles of family law, she was able to make a real difference to the lives of people within Salford.

***"I'd like to thank the Salford Foundation for giving me such an incredible opportunity to work on real life cases,"*** Millie said. ***"The charity provides a vital service in the Salford community, offering a safe space for women to access the help and support they need. I'm so glad I was able to be a part of the services offered. Learning in this practical way taught me to be personable and professional. I was required to carry out legal research across a range of different areas. The experience really helped to inform my decision to pursue a career in law after University."***

This includes Psychology, Sociology and Criminology.

Their service users are referred via the Probation Service, and our students are able to gain very useful experience working with them providing counselling and therapeutic support.
